The Cost of Attendance (COA) reflects an estimate of new MSN Health Systems Management student’s educational expenses for the 2019-20 academic year. Students enrolled less than full-time will incur less charges. Direct expenses that will be charged to students include tuition and, if applicable, a Matriculation fee. Indirect expenses, marked with an asterisk, are estimates and not charged directly by the University. MSN students are billed per credit for tuition at \$1,688 per credit.
