I have always enjoyed teaching at multiple levels. In the clinical realm, I am reminded that medicine is a tough profession—exact and unforgiving. The stakes are high, and the patients often feel vulnerable. When I am doing clinical teaching, I want the students and residents to understand the importance of three things: listening, sensitive communication both with patients and with colleagues, and knowing what the right questions are and how to go about answering them. Since good research starts with a good question, the last of these learning goals gets at my particular interest in teaching research methods and study design. While I have taught learners at all levels and served even as a classroom teacher of clinical skills, my educational focus is mentorship in research mentoring. I am proud to have served as primary mentor/on the mentoring panel of over a dozen career development awards. I have also run two "labs" of clinician researchers (Scientific Collaboration of Overweight and Obesity Prevention and Treatment at UNC-CH and the Duke Center for Childhood Obesity Research). Finally, I have served in leadership of two postdoctoral research fellowships (Associate Program Director of the NRSA fellowship at UNC-CH and Program Director of the National Clinician Scholars Program at Duke). Research Focus

My research expertise focuses on childhood obesity prevention and treatment and how pediatric care providers can prevent and treat obesity in the clinical setting, so children lead healthier lives. I studied body mass index screening, the ways physicians and families could sensitively communicate about a child's weight status, the health consequences and correlates of obesity, and the development of "toolkits" to aid providers and patients in mutual prevention and treatment efforts, the roots of obesity, and obesity-related stigma. In addition to obesity. I have studied primary care pediatrics, patient-oriented preventive care, child development and psychosocial well-being, health services research, health literacy, the built environment, culture of health, and health disparities and health equity. My work has been supported by numerous grants, including leading a multi-site randomized controlled trial NIH R01 (N=865; Latinx 50%; African American 28%) and its competitive renewal on obesity prevention and children's health and a multi-disciplinary and a team science grant (R24) exploring the connections between culture and health. I am now a Co-Principal Investigator on a PCORI proposal of a multi-site randomized controlled trial which has enrolled 900 parent-infant dyads and is following them through age 2.
