- 2024 – 2027 *The Johns Hopkins Nursing Science Incubator for SDOH Solutions (N-SISS): Preparing Innovators to Eliminate Health Inequities and Redesign Health*,
Funded by the National Institute of Nursing Research (NINR).
Total Cost: \$810,000 (MPI: Guilamo-Ramos & Farley)

N-SISS will leverage Johns Hopkins University's extensive research and training infrastructure as well as the program directors' national network of health equity researchers to strengthen the scientific nursing workforce's capacity to conduct impactful, innovative SDOH research to eliminate health inequities and redesign health.

- 2024 – 2029 *Community Screening, Intervention, and Navigation to Substance Use Prevention and Treatment Services to Eliminate Behavioral Health Inequities*, funded by the Substance Abuse and Mental Health Services Administration (SAMHSA).
Total Cost: \$4,967,269 (MPI: Guilamo-Ramos and Benzekri)

This project will implement a *Community Screening and Linkage to Substance Use Services* program in Mott Haven, NYC. Our project represents a comprehensive multicomponent community-based approach that integrates (1) the scale-up of a culturally and developmentally appropriate *Community SBIRT* model that offers a comprehensive set of behavioral health services directly in families' immediate context—their household; and (2) *Multi-Sectoral Partnerships* that leverage protective family influences to reduce the onset/progression of substance use and increase sustainable community capacity and systems trustworthiness for responding to behavioral health needs in the long term.

- 2023-2028 *Development and Evaluation of a Multilevel, Socio-Culturally Contextualized Digital Health Decision Intervention to Reduce Medical Mistrust and Improve Status-Neutral HIV Service Use among HLMSM*, funded by the Centers for Disease Control and Prevention (CDC).
Total Cost: \$2,500,000.00 (PI: Guilamo-Ramos)

This two-phased research study will conduct mixed-methods formative research and a 3-arm parallel explanatory randomized controlled trial to develop and evaluate a multilevel digital health intervention aimed at addressing medical mistrust and HIV service trustworthiness to improve status-neutral HIV service use among Hispanic/Latino gay, bisexual and other men who have sex with men (HLMSM).

2022-2027 *RCT of a parent-focused intervention to reduce HIV risk in adolescent MSM*, funded by the National Institutes of Health (NIH) and Mental Health (NIMH).
Total Cost: \$2,408,520 (Co-I: Guilamo-Ramos)

Gay and bisexual youth make up 80% of all new HIV infections among adolescents ages 14-19 in the United States, yet interventions to improve sexual health outcomes in these youth are extremely limited. Our team has developed an intervention to reduce HIV risk for gay and bisexual youth by working with their parents to improve the ways parents communicate with their sons about sexual health. We propose to deliver our intervention to parents of gay and bisexual teens ages 14-19 and to test whether it helps their sons by reducing sexual risks and increasing HIV testing.

2020-2024 *Families Talking Together: A Family-Based Approach to Promote Sexual Delay and Strengthen the Evidence Base for Sexual Risk Avoidance Education*, funded by the Administration for Children and Families (ACF).
Total Cost: \$1,336,071 (PI: Guilamo-Ramos)

This randomized controlled trial will evaluate the effectiveness of a novel, delivery mechanism for Families Talking Together Plus (FTT+), a family-based, online adolescent prevention intervention designed to promote adolescent sexual and reproductive health. Families randomized to the experimental condition will work with community health workers who will be trained as “life opportunity coaches” to deliver FTT+.

Completed Sponsored Projects

2018-2023 *A Father-Son Intervention to Reduce Risk Behavior and Inequality of Life Chances among Black and Latino Youth*, funded by the William T. Grant Foundation. Fathers Raising Responsible Men (FRRM) is a novel father-son intervention designed to reduce adolescent risk behavior and improve future life chances.
Total cost: \$600,000 (PI: Guilamo-Ramos)

This intervention draws on a theoretical framework of paternal influence designed to foster improved life chances thereby reducing inequality among adolescent males of color. The goal of this study is to reduce adolescent risk behavior by building capacity among father-son dyads for effective communication, greater father involvement, father role modeling related to the meaning of “manhood” and recognition of fathers as a lever to shape adolescent males’ future goals and aspirations.

2020-2023 *A Nurse-Community Health Worker-Family Partnership Model to Increase COVID-19 Testing in Urban Underserved and Vulnerable Communities*, funded by the National Institutes of Health (NIH).

Total Cost: \$4,817,346 (MPI: Guilamo-Ramos and Hagan)

This project aimed to evaluate the effectiveness of an innovative Nurse-Community Health Worker (CHW)-Family Partnership intervention designed to promote COVID-19 testing uptake, adoption of COVID-19 control measures, and mutual aid capacity at the household level. Endorsed by community members, this project extends the Nurse-Family Partnership model, which has been shown to be effective in improving maternal and child health outcomes, to include CHWs who will provide culturally-appropriate support to families, addressing stigma, medical mistrust, and other common barriers to engagement in COVID-19 testing and prevention for underserved communities and socially vulnerable populations.

2021-2023 *CLAFH Institute for Latinx Leadership Development in HIV*, funded by ViiV Healthcare.

Total Cost: \$300,000 (PI: Guilamo-Ramos and Hagan)

This project aimed to build leadership and strengthen Latinx-led organizations and coalitions nationally through the Instituto Latinx del Desarrollo Integral de Líderes Empoderados contra el SIDA (Instituto DILES; Latinx Comprehensive Development of Empowered Leaders against AIDS Institute [DILES (Tell Them) Institute]) that will develop a network of Latinx leaders for high-impact contributions towards ending the HIV epidemic among Latinx men. Three cohorts of DILES fellows (n=15 per cohort per year) will be enrolled and will receive empirically-grounded training and mentorship in four core HIV leadership competencies: (1) technical knowledge in HIV epidemiology and the Latinx HIV treatment continuum; (2) leadership skills in management/supervision, strategy, network analysis/development, and effective communication styles for advocacy; (3) personal leadership qualities in reflective leadership/stigma reduction, positionality, and commitment to continued personal development; and (4) supportive networks and connections between Latinx leaders nationally.

2012-2023 *Pilot Project and Mentoring Core*, Center for Drug Use and HIV Research P30 Center, Core Director, funded by NIDA. CDUHR is a P30 research center that addresses emerging challenges of the HIV epidemic by enhancing interdisciplinary research on HIV/AIDS and related infectious diseases among drug users.

Total cost: \$1,345,967 (PI Pilot and Mentoring Core: Guilamo-Ramos)

Dr. Guilamo-Ramos directs the Pilot Project and Mentoring Core, which promotes pilot testing of innovative research in the field of HIV/AIDS and substance use and seeks to increase the involvement and mentoring of underrepresented and early career investigators in the field. The Core will foster opportunities for mentorship and support for new or early-stage investigators

(those within 10 years of doctoral studies completion) by drawing on a conceptually-driven framework based on the empirical literature on mentoring.

2020-2021 *Educate, Test, and Navigate (ETN): A Comprehensive Peer-based Approach to HIV and Substance Misuse Prevention and Treatment Navigation for Minority Youth*, funded by the Substance Abuse and Mental Health Services Administration (SAMHSA).
Total Cost: \$1,000,000 (PI: Guilamo-Ramos)

The project aimed to utilize Educate, Test, and Navigate (ETN), a comprehensive peer-based approach to HIV and substance misuse prevention and treatment navigation for minority youth in NYC's South Bronx, the country's poorest congressional district and a hotspot for HIV and substance misuse. The project's overall goal is to provide developmentally appropriate services to AYA at the highest risk for HIV and SUDs through training and education about substance misuse and HIV, opportunities for testing and screening, and connections to service provisions for individuals at risk of or living with HIV and/or SUDs.

2019-2021 *Community Coalitions for Youth and Family Wellbeing*, funded by SAMHSA. Underage drinking and opioid use represent urgent national prevention priorities.
Total cost: \$1,500,000 (PI: Guilamo-Ramos)

This project aimed to implement and evaluate the impact of a community-wide evidence-based alcohol and opioid prevention program in the country's poorest congressional district and 'hotspot' for underage drinking and opioid overdoses—the South Bronx, NYC. Project activities at the individual, family, and community level are designed to saturate the target community and achieve sustained long-term change.

2019-2020 *Elevating Youth and Family Voices to Improve HIV Care: A Stigma Reduction Approach*, funded by ViiV Healthcare.
Total Cost: \$50,000 (PI: Guilamo-Ramos)

This project aimed to implement a series of educational workshops designed to elevate the voices of AYA living with HIV and their families in order to inform the development of innovative and replicable models for culturally and developmentally appropriate HIV primary health care. The workshops will elicit AYA and parent/caregiver perspectives regarding barriers and facilitators of retention in HIV care and adherence to ART; the impact of intersectional stigma and discrimination on HIV treatment outcomes, identity formation, and overall wellbeing; and the role of family members in supporting HIV care management, coping capacity, and resilience.

2018-2019 *Supporting HIV Testing, Linkage, and Retention in Care for Key Populations of the Dominican Republic*, funded by the MAC AIDS Fund.
Total cost: \$75,000 (PI: Guilamo-Ramos)

We implemented a comprehensive HIV-testing and risk-reduction intervention in the Dominican Republic that addressed major barriers to testing, linkage and retention to care. We focused on the city of Sosua, a global sex tourism destination. The research model involved training sex workers to serve as community health workers (CHWs) to deliver the “seek, test, treat, and retain model” (STTR).

2015-2018

Fathers Raising Responsible Men: Teen Pregnancy Prevention for Adolescent Males, funded by CDC.

Total cost: \$2,320,020 (PI: Guilamo-Ramos)

This project aimed to develop, evaluate, and disseminate a teen pregnancy, STI, and HIV prevention program specifically designed for ethnic minority adolescent males. This intervention was designed to facilitate important paternal parenting behaviors that influence adolescent decision-making. We used a novel, theoretically-based intervention highlighting the important and influential role that fathers have on the development of adolescent males. The goal of this study was to reduce adolescent male sexual risk behavior and to further develop the scientific evidence and intervention options targeted specifically to the teen pregnancy prevention needs of ethnic minority adolescent males.

2014-2017

Alcohol Use Among Mexican Youth along the U.S.–Mexico Border Region, funded by NIAAA.

Total cost: \$363,392 (PI: Guilamo-Ramos)

The project examined how recent economic transitions, governmental policies, social and familial processes shape Mexican adolescent alcohol use, utilizing an integrated micro and macro level framework to understand alcohol consumption among adolescents residing along the U.S. Mexico border. As rapid social, economic and political transitions greatly impact the U.S. population, the research addresses the implications of transitional contexts on individual vulnerability to alcohol use and related adolescent risk behaviors. The long-term goal of the research is to inform alcohol interventions targeting border youth and increase understanding of how transitional contextual processes influence risk behaviors in the current global environment.

2010-2016

Affective Influences on Adolescent Sexual Risk Behavior: Couple & Family Contexts, funded by the National Institute of Child Health and Development (NICHD).

Total cost: \$3,408,026 (PI: Guilamo-Ramos)

The project studied Latino and African American adolescents, their parents and their romantic partners, in order to gain a better understanding of the relevant dynamics surrounding adolescent sexual risk behavior. The aim of the research was to gain insight into the bases of adolescent sexual risk behavior by taking into account the family contexts and the couple contexts that affect sexual risky behavior. This knowledge can be used to inform the design of parent-based

prevention interventions to address risk behavior, as well as other forms of intervention, such as school-based programs.

2014-2016 *Psychosocial Service Utilization & Engagement in Care among Black and Latino Male Youth*, funded by the Clinical and Translational Science Institute (CTSI), NYU Langone Medical Center. Black and Latino young males in the Bronx experience extreme disparities across health and social welfare outcomes commonly linked with mental health and psychosocial disorders.
Total cost: \$50,000 (PI: Guilamo-Ramos)

The primary aims of the project were to develop scientifically grounded evidence-based best practice guidelines to promote the engagement and retention of black and Latino male youth and address unmet mental health and psychosocial well-being needs of a historically underserved population in critical need of care.

2015-2016 *HIV Testing Among Key Populations in the Dominican Republic*, funded by the MAC AIDS Fund.
Total cost: \$100,000 (PI: Guilamo-Ramos)

The project implemented a comprehensive HIV testing and risk reduction intervention in the Dominican Republic (DR) that addresses major barriers to testing and linkage to care. The overall goal was to increase HIV testing uptake among sex workers in tourism areas of the DR. We used a novel community participatory model by training sex workers to serve as community health workers to conduct outreach and deliver the program. Through this strategy, we accessed high-risk contexts where sex workers are concentrated. The anticipated result was an increase in HIV testing rates and protective health behaviors among sex workers in the Puerto Plata province where the majority of the area is rural and tourism is high.

2010-2016 *Reducing Sexual Risk Behavior: A Clinic Based Approach*, funded by the National Institute of Child Health and Development (NICHD).
Total Cost: \$3,181,450

The study sought to test and refine a parent-based intervention designed to prevent adolescent sexual risk behavior in Latino and African American inner-city populations. The intervention used a novel outreach approach relative to extant parent-based interventions. Specifically, the intervention took place in a primary healthcare clinic and was coordinated through allied health professionals when physicians see adolescents for their annual physical examinations. The overall goal of the research program was to further develop and evaluate a practical, effective, and cost-efficient parent intervention that can be used in healthcare settings that will reach large numbers of parents and prevent and/or reduce future adolescent sexual risk behavior.

2013-2014 *Families Talking Together: Preventing HIV/AIDS among At-Risk Dominican and Haitian Youth*, funded by the MAC AIDS Fund
Total Cost: \$50,000

The proposed project delivered an effective, family HIV prevention program designed to reduce the risk of HIV/AIDS among adolescents in Sosúa, DR. We tailored and implemented the Families Talking Together (FTT) program, which has been shown to significantly reduce rates of transitioning to sexual activity among Latino youth in high prevalence communities in the US. To best reach families in the Dominican Republic, we offered FTT through a community health worker, home-delivery approach while incorporating specialized content to address the unique health needs of youth in tourism areas.

2012-2014

Latino Male Adolescent Well-Being: The Role of Fathers in Disadvantaged Communities, funded by the New York Community Trust: Silberman Fund Faculty Grant Program.

Total cost: \$40,000 (PI: Guilamo-Ramos)

This research sought to understand how Latino fathers in the South Bronx influence the well-being of their adolescent male children in the current macro-social context of widening income disparities and increased immigration. The study was novel in that little research had explored the unique role of fathers in buffering the effects of economic and immigration-related inequities among their adolescent sons. Collected data was used to inform social work delivery by informing the design of targeted, evidence-based prevention interventions to improve the health and well-being of Latino males, such as Mayor Bloomberg's Young Men's Initiative.

2009-2014

Under Age Drinking in Latino Youth, funded by NIH. This research was a longitudinal study of young Latinos and their mothers.

Total cost: \$2,275,000 (Co-I: Guilamo-Ramos)

The primary aim of the proposed research was to examine how individual, cultural, and parental/familial factors contribute to drinking behavior among Latino youth. Specifically, we sought to understand the emergence of drinking activity during two crucial transitional periods (from grades 7 to 8 and then from grades 8 to 9).

2011-2012

HIV Transmission and Illicit Drug Use in a Caribbean Tourism Area, University of Global Public Health Research Challenge Fund, pilot funding from New York University.

Total cost: \$15,000 (PI: Guilamo-Ramos)

The primary aim of this project was to describe the role of illicit drug use in a tourism area of the Dominican Republic (DR). The research was significant in that it sought to examine an important risk factor for HIV transmission- illicit drug use, which had been neglected by current HIV prevention science efforts in the Caribbean.

2009-2011

Network Determinants of Risk among Formerly Incarcerated Latino Men, funded by the National Institute of Mental Health (NIMH).

Total cost: \$1,000,000 (Multiple PI: Guilamo-Ramos and Muñoz-Laboy)

The primary aim of the research study was to examine the familial and social network factors of drug use and sexual risk behavior among formerly incarcerated Latino men (FILM) in order to develop a network-based intervention to reduce HIV and sexually transmitted infections.
