

# **Pre-Enrollment Program Compliance Requirements**

This list of requirements may be updated each semester.

Prior to admission, this document should serve as a guide only. When you begin your compliance, please refer to the requirement instructions in Exxat for the most up-to-date instructions.

If you have been admitted for:	Please wait until:
the Fall semester	May 15 <sup>th</sup> to begin the compliance process. The compliance deadline is July 15th.
the Spring semester	October 15 <sup>th</sup> to begin the compliance process. The compliance deadline is December 15th.
the Summer semester	March 1 <sup>st</sup> to begin the compliance process. The compliance due date is May 1st.

## JHSON has partnered with Exxat Prism to manage student compliance.

As a newly admitted student, you will be required to purchase the compliance package components. On the day that you can begin compliance, you will receive an email invitation from Student Affairs, followed by an Exxat email with instructions for setting up your account.

All students are required to have an initial background check and drug screening as part of pre-enrollment compliance. Students will pay the initial cost of the compliance package (\$120) which includes the background check\* (\$55), the drug test\*\* (\$29), and the document and immunization record management module\*\*\* (\$36). MSN, Entry into Nursing students will also pay a one-time \$40 clinical placement fee after they are enrolled in their first course with a clinical component, and renew their background checks and drug tests yearly as required by clinical placement sites.

## Please note:

- \*If you have lived in New York State at any time in the past seven years, you will also be required to purchase a separate New York background check at an additional cost of \$108.
- \*If you have not lived in the United States <u>continuously</u> for the past 7 years, you will be required to purchase an international background
  check and the cost may be substantial. Once you have set up your compliance account with Exxat, please contact Student Affairs for further
  instructions.
- \*\*On the day of your drug test, avoid drinking more than one glass of water or other liquids within two to four hours of providing a sample, and avoid diuretics like coffee and tea within two hours of providing a sample. If you are required to drink a lot of water, schedule your test early in the day. A "Negative" drug test result is required. A "dilute negative" drug test result will not be accepted as a result for your drug screening, and you will be required to take another test at your expense.
- \*\*\*All vaccination and immunization documentation should show both your name and the collection/administration date.
- IMPORTANT any adverse drug test or background check results that cannot be resolved may affect your admission status.

REQUIRED TITERS AND IMMU	UNIZATIONS (Subject to update as CDC guidelines change)
MMR (Measles, Mumps & Rubella)	<ul> <li>One of the following is required:</li> <li>Positive Antibody titer for all 3 components, <u>OR</u></li> <li>2-vaccination series administered after 12 months of age. If the series is in process, submit where you are in the series and new alerts will be created for you to complete the series. If any titer is negative or equivocal you will be prompted to receive 1 boostershot.</li> </ul>
Varicella Zoster (Chicken Pox)	<ul> <li>History of disease is NOT acceptable. One of the following is required:         <ul> <li>Positive titer, OR</li> </ul> </li> <li>2-vaccine series at least 4 weeks apart. First vaccine must be administered prior to the start of the program. If titer is negative or equivocal you will be prompted to receive 1 booster shot.</li> </ul>
TDaP (Tetanus, Diphtheria, Pertussis)	Submit documentation of <b>TDaP or DTaP</b> vaccination (received on/after age 11) administered <b>within the last 10 years.</b> The vaccine <i>must include</i> the Pertussis component.

# Influenza/Flu Students who begin their program in the spring semester must submit documentation by the compliance due date. Students who begin in the summer and fall semesters, and currently enrolled students must upload documentation of the flu vaccine into their compliance account by November 15th of each year. New and current students can get a flu vaccine from their health care provider, or any other immunization provider. In concurrence with Center for Disease Control's recommendation, the nasal spray vaccine is not an acceptable flu vaccine and does not satisfy the flu vaccine compliance requirement. You must provide either a positive Hepatitis B Quantitative or Qualitative Surface Antibody titer, **Hepatitis B** OR documentation of a series in process. If you submit a positive surface antibody titer, no further action is required. If you do not have any titer documentation, or you have a titer drawn and the result is negative or equivocal, you will need to complete the 3-dose Engerix or 2-dose Heplisav-B series. Please read carefully. Master's Entry into Nursing students must submit TB screening results from within 6 months before the compliance due TB (Tuberculosis) date. PPD skin test, QuantiFERON, or T-spot results are acceptable. If results are negative, no further pre- enrollment testing is required for pre-enrollment compliance. OR, a clear chest x-ray report from within 12 months of the start of the **Tuberculosis** semester is also acceptable. Annual symptom reviews will also be required. **NOTE: Additional** All other programs must follow CDC guidelines for health care workers. If testing is not available, please submit your screening may be most recent negative test results and a current symptom review. required for specific clinical site placements. Any student with POSITIVE screening results must follow instructions 1-4 and continue annual screening renewal. Students with a positive TB test must submit official laboratory results of negative QuantiFERON Gold or T-Spot blood test. Students with a positive QuantiFERON Gold or T-Spot blood test must submit a clear chest x-ray\* (dated AFTER the positive PPD or QuantiFERON/T-spot results). If a student has a history of a positive QuantiFERON Gold or T-Spot blood test and a clear chest x- ray dated after the positive QuantiFERON or T-spot result but less than 10 years old, the patient can submit documentation\* reflecting this information along with a yearly TB symptom review completed by a licensed provider (most recent symptom review within 1 month of startdate). If a student has been treated for latent TB (Latent Tuberculosis Infection or LTBI), the student must submit documentation\* reflecting date of positive QuantiFERON or T-spot\* and negative chest x-ray\*, in addition to the name, dose, and duration of prophylactic medication regimen administered for LTBI along with an annual TB symptom questionnaire completed by a licensed provider (completed within 1 month of start date). \*Official lab reports must be attached Per CDC guidelines: Indicators of Risk for Tuberculosis at Baseline Health Care Personnel Assessment: • Temporary or permanent residence of ≥1 month in a country with a high TB rate, any country other than the United States, Canada, Australia, New Zealand, and those in Northern Europe or Western Europe

Current or planned immunosuppression, including human immunodeficiency virus (HIV)

Close contact with someone who has had infectious TB disease since the lastTB test

or other immunosuppressive medication

#### COVID-19 Vaccine

Based on ongoing CDC recommendations and updates from clinical sites on their current student Covid compliance requirements, Covid vaccines will be optional for students as a JHU compliance requirement.

Students may still be required to have a Covid vaccine if their clinical placement site requires it. Additional site compliances may be required of students on an individual basis.

This requirement is subject to update by the University and/or the School of Nursing at any time. Students will receive notification in a timely manner.

If required, documentation must include manufacturer. You must wait at least 90 days after recovering from COVID to receive another vaccine. If this is the case, please contact Student Affairs for assistance.

# Cardiopulmonary Resuscitation Certification (CPR)

Only the following courses offered by the American Heart Association are acceptable.

All courses MUST include both the in-person and online components.

- American Heart Association's Basic (BLS) course, OR
- American Heart Association's Advanced (ACLS) Life Support course OR
- American Heart Association's Pediatric Training for Healthcare Providers (PALS)

The renewal date will be set based on the expiration of your certification. If your certification expires while you are enrolled, you will be required to renew it at your expense, typically \$35-\$80.

Clinical Placement Waiver and Release This Waiver and Release is executed by the student to cover the student's participation in a clinical placement with an "Affiliate" of The Johns Hopkins Health System.

RN License – <u>Post-licensure students</u> <u>only</u> Students must submit evidence of current nursing licensure from the state where clinical and/or capstone courses will be completed. Please upload documentation from the state's licensing website, which will provide both the issue and expiration dates.
